

RELEASE AGREEMENT

THIS RELEASE AGREEMENT is made and entered into this ____ day of _____, 20____, between DOBERMAN RESCUE of Colorado (Hereinafter referred to as the Rescue Service), and _____ (Hereinafter referred to as Releaser, whether one or more persons).

WHEREAS, in order to protect the breed of the Doberman Pinscher, the Rescue Service does accept for placement from individuals, animal shelters, humane societies, and other persons and entities, Doberman Pinschers which are unwanted, abandoned, neglected, lost or mistreated; and

WHEREAS, the Rescue Service does attempt to place such dogs where possible in suitable homes in consideration for a fee to be determined in each case:

NOW, THEREFORE, it is agreed as follows:

1) The Rescue Service does agree to accept into the rescue program the following described dog:

2) It is expressly understood by the parties to this Release agreement that the releaser voluntarily releases the above described dog to the Rescue Service free and clear of any claim of ownership and guarantees that no claim of ownership will ever be made against such dog.

3) Releaser represents and warrants that Releaser is the sole owner of this dog and has the full and complete legal right to release said dog to the Rescue Service.

4) Releaser provides the following information regarding the temperament, behavior, characteristics, and medical problems and treatments of the dog being released:

5) Releaser further warrants that dog has never bitten any person.

6) The Rescue Service assumes all responsibility for the dog's actions after the dog is released. The Rescue Service agrees to hold the releaser harmless for any actions of the dog after it is released to the Rescue Service unless there is an undisclosed history of aggressive episodes involving biting. It is mutually agreed by both parties that the only exception shall be if the dog remains in the physical custody of Releaser as set forth in paragraph 7.

7) If the dog being released herein remains in the custody of Releaser until such time as the Rescue Service finds a suitable home for the dog, it is agreed that the dog is the sole property of the Rescue Service and that the Releaser will not dispose of the dog without prior consent of the Rescue Service.

8) This Contract is to be governed by the laws of the State of Colorado.
